

PPL Group Privacy Policy

Introduction

This is the privacy policy of Parking Partners (Management Services) Limited and Parking Partners Limited, collectively referred to as PPL Group for the purposes of this policy.

PPL Group respects your privacy and is committed to protecting your personal data. This privacy policy will inform you as to how we look after your personal data when you use our services, visit our websites (regardless of where you visit them from) or have any contact with us, and will tell you about your privacy rights and how the law protects you.

1. Important information and who we are

Purpose of this privacy policy

This privacy policy aims to give you information on how PPL Group collects and processes your personal data.

This includes through your use of our websites (www.parking-partners.co.uk and www.chelseabridgecarpark.com) including any data you may provide through the websites when you use contact forms, download any materials available on the websites or sign up for any services. It also includes any other sharing of data associated with our activities.

Our websites are not intended for children and we do not knowingly collect data relating to children.

Controller

PPL Group is made up of different legal entities, details of which can be found below under 'Contact details'. This privacy policy is issued on behalf of the Group so when we mention PPL Group, "we", "us" or "our" in this privacy policy, we are referring to the relevant company in PPL Group responsible for processing your data. Parking Partners (Management Services) Limited is the controller and responsible for the PPL Group listed websites. Complaints

You have a right to complain to us if you consider that we have breached data protection laws because of the way we have handled your data. Please note, complaints must first be directed to us, as data controller. Complaints should be directed to the email address provided in the Contact details section.

We consider ourselves to be at the forefront of how personal data should be held and processed and want every opportunity to find out where you may believe that not be the case.

We will acknowledge complaints within 30 days of receipt and keep you updated as to the progress of the investigation. Once our investigation of the complaint has been concluded, we will inform you of the outcome.

If you are dissatisfied with our response, you have the right to escalate your complaint to the Information Commissioner's Office (ICO).

Changes to the privacy policy and your duty to inform us of changes

We keep this privacy policy under regular review and may update it from time to time to reflect changes in our data processing practices, legal or regulatory requirements, or guidance from relevant authorities. We will always keep historic versions of this policy which can be provided if requested. This version was last updated on 3rd September 2026.

It is important that the personal data we hold about you is accurate and current. Please keep us informed if your personal data changes during your relationship with us.

Third-party website links

Our websites may include links to third-party websites, plug-ins and applications. Clicking on those links or enabling those connections may allow third parties to collect or share data about you. We do not control these third-party websites and are not responsible for their privacy statements. When you leave our websites, we encourage you to read the privacy policy of every website you visit. We cannot be held responsible if these third parties do not look after your data to the same level that we do.

2. The data we collect about you

Personal data, or personal information, means any information about an individual from which that person can be identified. It does not include data where the identity has been removed (anonymous data).

We may collect, use, store and transfer different kinds of personal data about you which we have grouped together as follows:

- **Identity Data** includes first name, last name, username or similar identifier, title, date of birth, photographic proof of identity, CCTV footage, vehicle registration and signature.
- **Contact Data** includes billing and/or home address, email address and telephone numbers.
- **Financial Data** includes bank account and/or payment details.

- **Transaction Data** includes details of services we have provided to you.
- **Technical Data** includes internet protocol (IP) address, your login data, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform and other technology on the devices you use to access our websites.
- **Profile Data** includes your username and password, downloads made by you, your interests, preferences, feedback and survey responses.
- **Usage Data** includes information about how you use our websites and services.
- **Marketing and Communications Data** includes your preferences in receiving marketing from us and your communication preferences.

We may also collect, use and share **Aggregated Data** such as statistical or demographic data for any purpose. Aggregated Data may be derived from your personal data but is not considered personal data in law as this data does **not** directly or indirectly reveal your identity. For example, we may aggregate your website Usage Data to calculate the percentage of users accessing a specific website feature. However, if we combine or connect Aggregated Data with your personal data so that it can directly or indirectly identify you, we treat the combined data as personal data which will be used in accordance with this privacy policy.

We do not typically collect any **Special Categories of Personal Data** about you (this includes details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinions, trade union membership, information about your health and genetic and biometric data) unless required for our recruitment and employment processes. Nor do we typically collect any information about criminal convictions and offences other than as part of our recruitment and employment processes. If the services we provide require us to receive this information (for example, because you have specific access or mobility requirements that we and others may need to be aware of) such requirement will be made clear to you and any such data we collect will be processed in accordance with the terms outlined in the contract in place between us.

If you fail to provide personal data

Where we need to collect personal data by law, or under the terms of a contract we have with you and you fail to provide that data when requested, we may not be able to perform the contract we have or are trying to enter into with you (for example, to provide you with goods or services). In this case, we may have to cancel a product or service you have with us but we will notify you if this is the case at the time.

3. How is your personal data collected?

We use different methods to collect data from and about you including through:

- **Direct interactions.** You may give us your Identity, Contact and Financial Data by filling in forms or by corresponding with us by post, phone, email or otherwise. This includes personal data you provide when you:
 - Communicate with us about, or enter into a contract for, our services;

- create an account on our websites;
- subscribe to our service or publications;
- download any resource available on our websites;
- request marketing to be sent to you; or
- give us some feedback.
- **Automated technologies or interactions.** As you interact with our websites, we may automatically collect Technical Data about your equipment, browsing actions and patterns. We collect this personal data by using cookies, server logs and other similar technologies.
- **Third parties or publicly available sources.** We may receive personal data about you from various third parties and public sources as set out below:
 - Technical Data from analytics providers, such as Google, based inside and outside the EU;
 - Contact, Financial and Transaction Data from providers of technical, payment and delivery services based inside the EU;
 - Identity and Contact Data from publicly available sources such as Companies House and the Electoral Register based inside the EU.

4. How we use your personal data

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

- Where we need to perform the contract we are about to enter into or have entered into with you.
- Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests.
- Where we need to comply with a legal or regulatory obligation.

Generally, we do not rely on consent as a legal basis for processing your personal data other than in relation to sending direct marketing communications to you via email or text message. You have the right to withdraw consent to marketing at any time by contacting us.

We do not currently use artificial intelligence (AI), automated decision-making, or profiling when providing our services or making decisions about any individual. Any decisions relating to our services are made by appropriately authorised, human personnel and are not based solely on automated processing.

Should our use of AI, automated decision-making or profiling change in the future, we will update this privacy policy accordingly and, where required by applicable data protection laws, provide further information about how such processing affects your personal data and rights.

Purposes for which we will use your personal data

We have set out below, in a table format, a description of all the ways we may use your personal data, and which of the legal bases we would rely on to do so. We have also identified what our legitimate interests would be where appropriate.

Note that we may process your personal data for more than one lawful ground depending on the specific purpose for which we are using your data. Please contact us if you need details about the specific legal ground we are relying on to process your personal data where more than one ground has been set out in the table below.

Marketing

We strive to provide you with choices regarding certain personal data uses, particularly around marketing and advertising. If you have any questions about how we are using your personal data to conduct marketing or advertising at you please contact us and we will be happy to answer any questions you may have.

Promotional offers from us

We may use your Identity, Contact, Technical, Usage and Profile Data to form a view on what we think you may want or need, or what may be of interest to you. This is how we decide which products, services and offers may be relevant for you (we call this marketing).

You may receive marketing communications from us if you have requested information from us or purchased services from us, or if you provided us with your details and consent when you downloaded resources from our websites, and, in each case, you have not opted out of receiving that marketing or withdrawn your consent.

Third-party marketing

PPL Group does not provide any of its personal data to third parties for the purposes of enabling them to market to you. If you receive marketing from a third party who claims to have received your personal data from PPL Group please do let us know immediately and we will investigate their claims and provide you with a clear explanation as to how we believe they may have got your personal data and whether they have received it from PPL Group.

Opting out

You can ask us to stop sending you marketing messages at any time by contacting us or by following the opt-out links within any marketing communication sent to you.

Where you opt out of receiving these marketing messages, this will not apply to personal data provided to us as a result of any use you make of PPL Group services, which we will continue to process in accordance with this privacy policy and pursuant to the contractual obligations between us.

Change of purpose

We will only use your personal data for the purposes for which we collected it, unless we reasonably consider that we need to use it for another reason and that reason is compatible with the original purpose.

If you wish to get an explanation as to how the processing for the new purpose is compatible with the original purpose, please contact us.

If we need to use your personal data for an unrelated purpose, we will notify you and we will explain the legal basis which allows us to do so.

Please note that we may process your personal data without your knowledge or consent, in compliance with the above rules, where this is required or permitted by law.

5. Disclosures of your personal data

We may have to share your personal data with the parties set out below for the purposes set out in the table in paragraph 4 above.

- Third Parties as set out in the *Glossary*.
- Third parties to whom we may choose to sell, transfer, or merge parts of our business or our assets. Alternatively, we may seek to acquire other businesses or merge with them. If a change happens to our business, then the new owners may use your personal data in the same way as set out in this privacy policy.

We require all third parties to respect the security of your personal data and to treat it in accordance with the law. We do not allow our third-party service providers to use your personal data for their own purposes and only permit them to process your personal data for specified purposes and in accordance with our instructions.

6. International transfers

We do not transfer your personal data outside the UK.

7. Data security

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors and other third parties who have a business need to know. They will only process your personal data on our instructions and they are subject to a duty of confidentiality.

We have put in place procedures to deal with any suspected personal data breach and will notify you and any applicable regulator of a breach where we are legally required to do so.

8. Data retention

How long will you use my personal data for?

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

To determine the appropriate retention period for personal data, we consider the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorised use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal requirements.

In some circumstances we may anonymise your personal data (so that it can no longer be associated with you) for research or statistical purposes in which case we may use this information indefinitely without further notice to you.

- In addition to the above you also have the right to withdraw consent to processing where the processing we are undertaking is being done so with you having given consent to it.

If you wish to exercise any of the rights set out above, please contact us.

Data requests

You will not have to pay a fee to access your personal data (or to exercise any of the other rights). However, we may charge a reasonable fee if your request is clearly unfounded, repetitive or excessive. Alternatively, we may refuse to comply with data requests that are not reasonable or proportionate.

What we may need from you

We may need to request specific information from you to help us confirm your identity and ensure your right to access your personal data (or to exercise any of your other rights). This is a security measure to ensure that personal data is not disclosed to any person who has no right to receive it. We may also contact you to ask you for further information in relation to your request to speed up our response.

Time limit to respond

We try to respond to all legitimate requests within one month. Occasionally it may take us longer than a month if your request is particularly complex or you have made a number of requests. In this case, we will notify you and keep you updated.

10. Glossary

LAWFUL BASIS

Legitimate Interest means the interest of our business in conducting and managing our business to enable us to give you the best service/product and the best and most secure experience. We make sure we consider and balance any potential impact on you (both positive and negative) and your rights before we process your personal data for our legitimate interests. We do not use your personal data for activities where our interests are overridden by the impact on you (unless we have your consent or are otherwise required or permitted to by law). You can obtain further information about how we assess our legitimate interests against any potential impact on you in respect of specific activities by contacting us.

Performance of Contract means processing your data where it is necessary for the performance of a contract to which you are a party or to take steps at your request before entering into such a contract.

Comply with a legal or regulatory obligation means processing your personal data where it is necessary for compliance with a legal or regulatory obligation that we are subject to.

THIRD PARTIES

Third Parties

- The different members of the PPL Group are independent companies that share common facilities and resources. Each member of the PPL Group will be acting as a processor for each of the other members of the PPL Group if and to the extent that it provides administration, management, IT, facilities or employee services to that other PPL Group company.

- Service providers, acting as processors, based within the UK who provide: IT and system administration services, remote payment services, other car park services e.g. electric vehicle charging services, enforcement or debt collection services.
- Professional advisers, acting as processors, including lawyers, bankers, auditors and insurers based within the United Kingdom who provide consultancy, banking, legal, insurance and accounting services.
- HM Revenue & Customs, regulators and other authorities acting as processors or joint controllers based in the United Kingdom who require reporting of processing activities in certain circumstances.

YOUR LEGAL RIGHTS

You have the right to:

Request access to your personal data (commonly known as a "data subject access request"). This enables you to receive a copy of the personal data we hold about you and to check that we are lawfully processing it. Your right to your personal data does not necessarily include a right to access or see content that is commercially sensitive or that may reveal another person's personal data. Where this is the case it will be made apparent to you, together with our reasoning for withholding any such data, when we respond to your data subject access request. Request correction of the personal data that we hold about you. This enables you to have any incomplete or inaccurate data we hold about you corrected, though we may need to verify the accuracy of the new data you provide to us.

Request erasure of your personal data. This enables you to ask us to delete or remove personal data where there is no good reason for us continuing to process it. You also have the right to ask us to delete or remove your personal data where you have successfully exercised your right to object to processing (see below), where we may have processed your information unlawfully or where we are required to erase your personal data to comply with local law. Note, however, that we may not always be able to comply with your request of erasure for specific legal reasons which will be notified to you, if applicable, at the time of your request.

Object to processing of your personal data where we are relying on a legitimate interest (or those of a third party) and there is something about your particular situation which makes you want to object to processing on this ground as you feel it impacts on your fundamental rights and freedoms. You also have the right to object where we are processing your personal data for direct marketing purposes. In some cases, we may demonstrate that we have compelling legitimate grounds to process your information which override your rights and freedoms.

Request restriction of processing of your personal data. This enables you to ask us to suspend the processing of your personal data in the following scenarios: (a) if you want us to establish the data's accuracy; (b) where our use of the data is unlawful but you do not want us to erase it; (c) where you need us to hold the data even if we no longer require it as you need it to establish, exercise or defend

legal claims; or (d) you have objected to our use of your data but we need to verify whether we have overriding legitimate grounds to use it.

Request the transfer of your personal data to you or to a third party. We will provide to you, or a third party you have chosen, your personal data in a structured, commonly used, machine-readable format. Note that this right only applies to automated information which you initially provided consent for us to use or where we used the information to perform a contract with you.

Withdraw consent at any time where we are relying on consent to process your personal data. However, this will not affect the lawfulness of any processing carried out before you withdraw your consent. If you withdraw your consent, we (or third party service providers) may not be able to provide certain products or services to you. We will advise you if this is the case at the time you withdraw your consent.

Make a complaint about how your data has been handled by us as data controller. You have the right to complain directly to us if you consider that we have breached data protection laws because of the way we have handled your personal data (or the personal data of someone you are acting on behalf of).
